2024 Stock Contractor Request for Bid

2024 Rodeo Season Dates

Bid Terms & Conditions:

1. The CJCA rodeos will not be a place to train or break-in stock. All stock should have previous experience. *7-10 age group Calf Riding excluded.
2. Chute Dogging and Team Roping steers should be even in weight, horn length, and size.
3. Tie-Down Roping calves should be smaller than Breakaway Roping calves, and even in weight in size.
4. All calves used in Breakaway Roping must have less than 2-inch horn length and should be even in weight and size.
5. All timed-event stock should be within the weight limit range designated in the CJCA Rulebook for each event.
6. All stock contractors are required to provide transportation for stock to and from the rodeo.
7. CJCA will provide hay for all animals. The Stock Contractor is responsible for providing any grain in their feeding program.
8. Stock contractors are required to bring enough stock for each rodeo event, including re-rides.
9. All stock should arrive and be unloaded at least two (2) hours prior to the start of the rodeo.
10. CJCA may terminate the Stock Agreement immediately, upon written notice, if the Stock Contractor fails to comply with the Bid Terms & Conditions of the agreement.
11. For any material breach of the Bid Terms & Conditions of the agreement, CJCA reserves the right to reasonably adjust or reduce payments to the Stock Contractor to satisfy any damages to the CJCA by the Stock Contractor's breach.
